4. Matters Arising:

Camping Spots: The Council have said that going forward we are going to need planning permission for the Camping Spots along with licences to operate those Spots. Linda is waiting for more information from planning about what they will require. **Tourism Warden:** Funding is being sought to extend Clara's role to include a tourism warden part. This would continue her role until September.
